Preface.

THE College at Cumbrae was established in the year 1849. The primary object of the Foundation has been throughout the frequent Celebration of Divine Service by a Collegiate body, under circumstances favourable to religious learning; the second, Education. In regard to the latter, certain changes were made in 1853; the northern wing of the College, which had been assigned to the Junior Scholars and Choristers, having been subsequently devoted to the reception of young men preparing for the English Universities, or residing there during the Long Vacation, or at any other period of the year, in preparation for the University Examinations.* The southern wing of the College has continued from the first to be the residence of the Canons—of Clergy desiring to be received there for a time for rest or special study, or literary labours—and of Theological Students.

The foundation stone of the Collegiate Church was laid on May 29, 1849, and it was opened for Divine Service on Whitsunday, 1851. The south wing of the College-or Canons' House-was opened on November 18, 1850, and the northern wing, then called the Choristers' House, on October 9. 1851. On the eve of St. Peter's Day, June 28, 1854, the late Right Rev. Alexander Ewing, D.D., Bishop of the Diocese, was installed as Provost of the Church and College, which office he continued to hold until January, 1867, when he intimated his wish that the Rev. J. G. Cazenove, who for upwards of twelve years had acted as vice-Provost, should be made *Provost*. The Founder assenting to the Bishop's nomination, the Rev. J. G. Cazenove was installed as Provost on February 24.

^{*} Some few changes in this department have been (1875) now made; it having been determined to give more particular attention to the reception of Theological Students. Particulars will be found in another part of the Calendar.

PREFACE.

1867, which office he continued to hold until May 18, 1875, when on his resignation, the Rev. F. R. H. Herbert Noyes, D.D., was appointed and duly installed as Provost on June 9, 1875. (Dr. Cazenove retaining his seniority as a Canon of 1854.) On the same day the Founder made over by a Trust Conveyance Deed to certain Trustees,[†] on behalf of the Scottish Episcopal Church, the Collegiate Church, Buildings and Grounds, and certain adjoining Properties together with other Securities, as a further Endowment of the College. All legal impediments being now removed, the Collegiate Church was Consecrated on May 3, 1876, by the Right Rev. the Bishop of the Diocese (Dr. Mackarness), in the presence of the Most Rev. the Primus of Scotland (Dr. Eden), the Bishop of Tennessee (Dr. Quintard), and upwards of 70 other Clergy and a large number of the Laity of the Diocese. Immediately after the Deed of Consecration was signed, the Bishop, in accordance with the advice and assent of the Diocesan Synod, given in 1853 and 1875, declared the Collegiate Church to be henceforth

TO all and sundry whom these presents may or do concers, We, George Burnett, Esquire, Advocate, Lyon King of Arms, send greeting :--

WHEREAS the Provost and Chapter of the College of the HOLY SPIRIT, in the Parish of Cumbrae and County of Bute, have, by Petition of date the Thirteenth day of November current, prayed that we would grant our Licence and Authority to them and to their successors in office to bear and use, for official purposes connected with the said College, such Ensigns Armorial as might be found suitable and according to the Laws of Arms: Know ye therefore that we have devised, and do by these presents Assign, Ratify, and Confirm to the said Provost and Chapter and to their successors in office and to the said College the following Ensigns Armorial as depicted upon the margin hereof, and matriculated of even date with these presents in our Public Register of all arms and bearings in Scotland-viz., Quarterly, first and fourth grand quarters, Azure, S. Columba in a boat at sea; on his sinister hand a dove, and in dexter chief a blazing star, all proper; second and third grand quarters counter-quartered first and fourth, Or, an eagle displayed with two heads, gules, armed and beaked, azure: second and third, parted per bend embattled, gules and argent; in an Escutcheon of Pretence in the centre of the second and third grand quarters, Or, three stags' horns, gules .- In testimony whereof these presents are subscribed by us and the seal of our office is appended hereunto, at Edinburgh the Thirtieth day of November, in the year of our Lord eighteen hundred and seventy-four.

CUMBRAE COLLEGE.

THE Island of Cumbrae, on which this College is built, is situated near the entrance of the Firth of Clyde, and commands an extensive view of the beautiful Islands of Arran and Bute, with a portion of Ayrshire-a view of part of Argyllshire, and the end of the Grampian chain of hills. The north part of the Island is low, but as the visitor approaches the little town of Millport, on the east side of the Island the coast presents to his view bold cliffs covered with verdure, and a rocky shore—a portion of which has assumed the shape of a lion, apparently entering a cave, and which has hence been called the "Lion Rock." The Town of Millport* stands on the shores of a little bay to the westward of these cliffs, by which it is entirely concealed from the view of any one approaching in the steamers from Glasgow or Wemyss Bay. As the vessel turns the extreme south-east point of the bay the different objects present themselves one by one, as in a panorama; first, the houses near the Pier-then the Parish Kirk standing on the high ground above the village,-then close to the shore, "The Garrison," a residence of the Earl of Glasgow, the Founder of the College,then the spire and tower of the Cathedral come in view, followed by the Collegiate buildings, standing on a series of terraces, in grounds which have been laid out with great taste and skill. The houses which stand on the eastern shore of the bay complete one of the prettiest home-views which the traveller will meet with in these parts.

Landing on the Pier, and proceeding along the shore, the visitor having passed on the left The Garrison, arrives at a road which, passing between the grounds of The Garrison and those of the

^{*} The Town or Burgh of Millport has, according to the Census of 1871, about 1618 inhabitants, though this number is, at least, trebled in Summer. It is about 35 miles distant S.W. from Glasgow, and is reached by Steamer in 4 hours, or *Vià* Wemyss Bay Railway and Steamer in 2 hours. Leaving London at 8.40 p.m., by Limited Mail, Passengers can arrive at Millport about 10.30 a.m. the following day.

College leads to the principal gate of the latter. Passing through the gate the visitor finds himself within an enclosure of about twelve acres, and directly in front of the Cathedral and the College buildings, placed at the top of a succession of terraces, approached by flights of steps. The thickly-wooded and irregular copse, seen on the right of the entrance gate, will give an idea of the nature of the ground originally. Towards the left is seen standing prominently out, the Cemetery, which stands to the north-west of the Cathedral, and is approached by a stone Lich-gateway at its western side,—a path running round the outside of the boundary wall on the north, west, and south sides; the eastern end having for its boundary the slope of the terrace above, on which the Cathedral stands. At the east end of the Cemetery, opposite the Lich-gate, is a large stone Cross-similar in design to those in Iona.

From this point, too (for we suppose the visitor to be still pausing at the entrance gate of the grounds), the best view of the entire group of the College buildings is obtained. The Cathedral occupies the centre, stretching from east to west, the west window is seen facing the spectator. The southern wing of the building is called the Canons' House, as being the residence of the Clergy, who are members of the College. Here also are lodged any other Clergy residing for the purpose of retirement and study, or as guests; as also the Theological Students. The plate-glass windows, seen in the lower part of the building, give light to two spacious Libraries, one of which is allotted to the Clergy. The dormer windows in the roof light their bed-rooms and studies. ranged on either side of a corridor running the entire length of the building. In the bell-turret, which with good architectural effect breaks this length, are two bells which are rung at certain hours for the private purposes of the College. The arrangement of the northern wing of the building is similar to that of the south wing.

On going up the flights of steps at the end of the broad entrance walk, and passing round the east side of the College, a cloister is seen forming two sides of a small quadrangle, intended to be completed hereafter, while beside it appear the end of the College Hall, and that of the Chapter-House adjoining the Cathedral,

having five lancet windows. Both Cathedral and College are built of the delicately coloured freestone of the Island, procured from a quarry within the grounds.

But to return to the entrance path. On ascending the flight of steps we find ourselves on the first terrace, —the path leading forward by another flight of steps to a second terrace, and northwards by steps again to the Cathedral. The tower and spire are most beautifully proportioned, —the spire being four-sided, terminating with a large iron cross surmounted by a cock; the line of the spire being carried down to the ground by bold buttresses. The tower contains three bells, and a clock which chimes every quarter of an hour.

The Nave of the Cathedral is entered at the south-western door. It has plain oak chairs for the use of the people, and is lighted by four windows on the south side, filled with stained glass by Hardman-the two nearest the Choir containing representations of the Four Latin Doctors : St. Jerome, St. Ambrose, St. Augustine, and St. Gregory, being presented by the Earl of Glasgow in memory of the Rev. John Keble (author of the Christian Year), for some time an Honorary Canon of the Collegiate Church. The next window containing St. Catherine of Egypt, and St. Cecilia-presented by the Rev. Canon Keigwin in memory of his two sistersand the window nearest the west end, containing St. Ignatius and St. Polycarp, being placed there by some of his fellow-students in memory of Mr. G. W. Manuel Dasent, student of Christ Church, Oxford, and also of this College, who was drowned near Oxford in 1872. The west window is filled with stained glass of geometrical pattern by Wailes, and is the gift of those who had been employed in building the Cathedral and College. There is a row of several hundred gas lights running round the Nave. The pulpit stands on the north side. The Nave is separated from the Choir by a stone screen, having brass gates. The pillars on either side of the gates are of polished Aberdeen granite, and branch out above into tracery of stone, having in the middle an embossed cross.

The two massive gates are of polished brass, each having a finial

formed of imitations of the fern leaf. The low screen is surmounted by a tracery in brass, consisting of a series of quatrefoils. The whole of the walls of the Choir, and the front of the screen and label of the Chancel arch, are adorned with encaustic tiles of various colours arranged in patterns, portions being filled in with Parian cement, for the introduction of frescoes. The floor also has various patterns of tiles. On the roof are represented the ferns and flowers abounding on the Island.

The windows of the Choir are all of stained glass, by Hardman. The south window nearest the Nave represents the Crucifixion of our LORD, with the words "IT IS FINISHED," presented in memory of Lady Eleanor Law, who died whilst on a visit to the Island. The next, of which the colouring is peculiarly rich, represents our LORD's Resurrection. It was presented by the Rev. G. C. White, formerly Provost of the College. There is also inserted in the north wall near the arch a Memorial Brass, given by some of his fellow-students, in memory of Mr. W. Anstruther Robertson, of Oriel College, Oxford, and a Student of this College, who died before completing his University course.

In the north wall of the Sacrarium is a stone Credence, with an Aumbrye closed by a brass door, which is pierced with tracery work. The Altar is duly vested, and has on it a gilt cross and brass candlesticks. The Altar Cross and the vessels for Holy Communion are richly studded with precious stones, those for the Flagon and Chalice having been presented by the Rev. F. H. Freeth, formerly Canon and Chanter of the College.

The east end of the Chancel, up to the base of the east window, is covered with velvet hangings. To the north of the Choir is an arch-way leading to the north vestry, in which stands the Organ, the pipes of which are painted with blue and gold. Beyond the vestry is the Chapter-House, and from this a door opens into a little court paved in diamonds with black and white pebbles, which leads, on the left, to the north wing of the College,—and on the right, to the Cloisters, from which open the Dining Hall, and the residence of the Clergy, &c.

The Dining Hall stands between the court and the north cloister,

it is a plain building, with an open high-pitched roof, an east window with stone tracery, under which stands the high table, for the Clergy and Graduates of the Universities, on a raised dais, while the other tables for the Students, &c., occupy the sides of the Hall. Passing from the Hall through the western cloister, we enter the residence house of the Clergy. Here are two large Libraries, with some small Studies, and a Sacristy communicating with the south side of the Chancel. Upstairs are the dormitories, bath-room, &c., and on the basement are the kitchen and various offices. Outside the cloister is a temporary wooden building, containing a spacious Reading Room for the use of the Students.

From the terrace on the west side of the Canons' House, a magnificent view of the mountains of Arran and the surrounding scenery is obtained; and, descending from this, along a path which leads to a copse overhanging the quarry, from which the stone for the buildings was procured, at the southern extremity of the College grounds, we come upon another view of the coast of Ayrshire, the Little Cumbrae, and—far off in the distance, in the midst of the sea—Ailsa Craig. Above the path last mentioned is another terrace, on a level with the cloister, on which a Bowling Green has been formed for the use of the members of the College.

Objects of the Foundation.

THE chief end and objects for which the Church and College are founded are these :---

"1.—The worship and service of Almighty GOD, by daily prayer and frequent celebration of the Holy Communion.

"2.—To seek to promote the welfare of the Diocese by placing at the disposal of the Bishop a certain number of Clergy, who, under his direction, shall minister to such members of the Church as cannot afford a resident Pastor, and would otherwise be precluded from many spiritual privileges; and, further, to afford assistance to the Clergy of the Diocese, when, from time to time, it may be needed.

"3—.To afford a retreat to a limited number of aged and infirm Clergymen, who, incapable of active pastoral labour, seek to spend the close of their life in the worship and service of Almighty GoD, and in preparing to render an account of their stewardship.

"To afford education and maintenance to two or three Students preparing for the service of the Church, more especially in the Gaelic districts.

"It is further intended to offer assistance in their studies to a certain number of young men before and during their University course, and to such as desire to read in the College in preparation for Holy Orders (ordinarily after having taken a University Degree).

Of the Clergy.

"It is intended that a Provost, and from four to six Clergy, shall be attached to the Church and College.

"Certain of them will be (A).....Resident.

(B).....Missionary.

- "(A) The Clergy in residence will consist of-
 - "The Provost.
 - "Two of the Clergy (one of whom may be Vice-Provost), engaged—

"1.-In serving the Collegiate Church.

- "1.—In the education of Students before and after their University course.
- "Two or three aged or infirm Clergymen, incapable of active pastoral labour, yet desiring to spend the remainder of their lives in the daily worship and service of Almighty GoD, serving in the Collegiate Church.
- "(B) Two of the Clergy (at the least) will eventually be placed at the disposal of the Bishop, and ready to act as supernumerary Clergy in the Diocese, and undertake such missions as he may direct, so soon as a sufficient income has been provided for those in residence.

"It is intended that lodgings in the College, or in houses within its precincts, shall be provided for the aged or infirm Clergy; but until such times as an Endowment is raised they will be expected to maintain themselves."

This statement of the Objects of the Foundation as given above, and the Constitution together with the Statement as to the future position of the Collegiate Church in the Diocese, received the approval of the Synod of Argyll and The Isles, held at Lochgilphead, August 3, 1853, and it was ununimously resolved,—

"That the grateful thanks of this Synod be offered to the Founder of the Collegiate Church and College of Cumbrae for his great liberality in founding such an Institution, which is calculated to be of the utmost importance and utility in forwarding the best interests of the Church: And, further, that this Synod having adopted on the above basis this Church and College as an integral portion of the working power of the Diocese, prays that Almighty GoD may sanction and bless the same, and render it conducive to the best interests of His holy religion."

At the Diocesan Synod of Argyll and The Isles, held at Lochgliphead on September 23, 1875, the Bishop in his Charge alluded to the Theological College, established by Lord Glasgow, in the Island of Cumbrae, which, together with an Endowment, had recently been made over to the Church. All obstacles to the Consecration of the Collegiate Church of Cumbrae having been thus removed, the Synod unanimously agreed,—

"That the Collegiate Church of Cumbrae should be recognized as the CATHEDRAL OF THE DIOCESE OF THE ISLES, and the thanks of the Synod be presented to the Earl of Glasgow for his munificent gift to the Church."

CONSTITUTION.

EPISCOPAL RATIFICATION (1853).

"WE, Alexander, by Divine Permission, Bishop of Argyll and The Isles, do by these presents make known unto all faithful persons that we have carefully considered, and by the advice of our Diocesan Synod have formally ratified and confirmed, the Constitution for the Collegiate Church and College of Cumbrae presented unto us by our well-beloved son in CHRIST, George Frederick Boyle, Founder of the aforesaid Church and College, which hereinafter followeth."

*** Additions to this Constitution, or alterations therein, may be made by the Bishop of the Diocese, with the concurrence of the Founder; but none such will be made without the assent of the majority of the Chapter.

It is purposed that the Church and College shall eventually become the "CATHEDBAL SEAT OF THE ISLES," within the United Dioceses.

PREAMBLE (1853).

IN the NAME of the FATHER, and of the SON, and of the HOLY GHOST, in One Glorious and Undivided Trinity, Three Persons, and One GOD.

"I, George Frederick Boyle, considering how blessed a work it is to rear a Temple to the Most High God, wherein His praises may be duly celebrated, His Sacraments administered, and His Holy Word preached; and considering also the spiritual necessities of this Church and Diocese, and how needful it is that Priests, Deacons, and other Ministers of the Church should be maintained and educated, who may constantly offer unto Him the Sacrifice of praise, and make known unto men the unsearchable riches of CHRIST, have caused to be erected a Collegiate Church, with a College attached to it, which I have offered and dedicated to the THIRD PERSON of the Ever Blessed TRINITY, under the name of the 'Church and College of the HOLY SPIRIT,' with the Constitution following; and have, moreover, provided an Endowment for the Provost and Canons who shall serve the aforesaid Church, aid the Bishop of the Diocese in feeding the flock committed to his care, and train in sound religion and useful learning such Students and Scholars as may be resident within the College or its precincts."

CODE OF STATUTES.

AS REVISED AND RATIFIED, 1876.

I.-OF THE DEDICATION.

The Church and College are dedicated more especially to the honour and glory of The THIRD PERSON of the Ever Blessed TRINITY.

II.—OF EPISCOPAL JURISDICTION.

The Provost, Canons, and all other Members of the Foundation, being in full communion with that portion of the Church Catholic now commonly called "The Scottish Episcopal Church," are under Canonical obedience to the Bishop of The Isles, and subject to his authority, as all other Clergy within his Diocese. The Bishop shall at all times be entitled to preach—and, in relation to all Episcopal and Diocesan Functions, to regulate the hours and details of the several Services in connection therewith—in the Cathedral Church. When any Agreement shall have been made between the Bishop and the Provost and Chapter as to the existing Customs and Usages of the Cathedral and Collegiate Church aforesaid, all additions at any time to such Usages and Customs shall be subject to the control of the Bishop. In the event of no such Consuetudinary having been established, the Bishop shall, under his hand and seal, be entitled to restrain all additions to, or alterations in, the Usages and Customs of which he may disapprove—such power being publicly and formally exercised, and subject to such appeal as the Canons of this Church may sanction. No Bye-laws enacted by the Chapter shall be valid until they have received the sanction of the Bishop. No Missions shall be undertaken but in his name, and by his commission.

III.---OF THE VISITOR.

The Bishop of The Isles shall be, *ex-officio*, Visitor of the College, with all the powers inherent in that office. It shall be in his power to hold a Visitation whensoever to him may seem fit. It shall be in the power of the Bishop to remove or suspend the Occupant of any Stall for breach of the Statutes, habitual neglect of duty, or any other grave error in life or doctrine, if the charge brought against him shall be considered, by the majority of the Chapter, as fully established; nor shall it be in his power to appeal from such sentence to any Court, Civil or Ecclesiastical, other than the Episcopal Synod.

IV.-OF THE CHAPTER.

The Chapter is intended to consist of a Provost and at the least three Canons. The Provost and Canons shall be appointed by the Bishop and the Founder jointly. After the decease of the Founder, the Provost shall be appointed by the Bishop. The Canons—one by the Representative of the Founder in the Earldom of Glasgow, if he be in full communion with the Episcopal Church of Scotland—one by the Canons, and the remainder by the Bishop and Provost jointly.* The Chapter shall hold a Meeting at such time as the Bishop or Provost may determine, and is empowered to draw up such Bye-laws as from time to time may be needed. The Provost and Resident Canons shall be entitled to three votes in Chapter; non-Resident Canons to two votes; Honorary Canons to one vote each.

- 2.—The Bishop and Provost jointly.
- 3.—The Canons.

In case of no appointment being made within six months after a vacancy has occurred, the appointment shall lapse to the next in rotation.

^{*} The rotation of appointment of Canons under Statute 1V. after the decease of the Founder shall be as follows :---

^{1.--}Representative of the Founder in the Earldom of Glasgow.

V.-OF THE PROVOST.

To the Provost shall appertain the government of the entire Institution; the control of all the details of Divine Service, not ruled by formal Agreement with the Bishop, or by formal Acts of the Chapter; the direction (under the Bishop) of all Missions undertaken by the Canons or other Clergy attached to the College; the charge of the fabric of the Cathedral and Collegiate Church, grounds, and buildings, jointly with the Founder; and the Cure of Souls within the College.

VI.—OF THE CANONS.

One of the Canons may be appointed by the Provost to act as Vice-Provost, and assist in the education of the Students. The other Canons shall serve the Cathedral and Collegiate Church, and undertake such Missions as the Bishop and the Provost shall appoint. In the event of a Canon, or Honorary Canon, being appointed to and accepting the Provostship, he shall be held, *ipso facto*, to resign his Canonry. The Dean of the Diocese shall be, *ex-officio*, entitled to a Canon's Stall within the Cathedral.

VII.—OF THE HONORARY CANONS.

There may be at least six Honorary Canons, appointed alternately by the Bishop and the Founder; after the decease of the Founder, alternately by the Bishop and a majority of the Chapter. Two additional Stalls shall be at the disposal of the Bishop, to be assigned by him to Clergy resident and officiating in the Diocese. The Honorary Canons may officiate in the Cathedral and Collegiate Church, and shall be entitled to a seat in the Chapter, and may give their votes orally or in writing.

VIII.—OF AGED OR INFIRM CLERGY.

A limited number of aged or infirm Clergymen (appointed by the Bishop and the Provost) may be permitted to reside in the College, or in houses within its precincts, and to officiate in the Cathedral and Collegiate Church. They shall be severally required to bring a "bene decessit" from their late Diocesan, together with the usual Testimonials, and on their presentation will receive from the Bishop license (which shall be revocable) to reside within the precincts of the College, and to officiate in the Church; and without a license no person shall be considered entitled to reside.

IX.—OF DIVINE SERVICE.

Morning and Evening Prayer shall be daily used in the Church, and the Holy Eucharist shall be celebrated, at the least, every Sunday, and on all Holy-Days.

X.-OF THE STUDENTS.

The Provost shall receive into the College a certain number of Students; they may consist of young men preparing for Holy Orders, or desirous of residing at the College in preparation for, or during their University Course. No Student may ordinarily be admitted who is not *above* sixteen years of age (in the case of those preparing for the Universities), and in all cases they may be required to produce such Testimonials as are satisfactory to the Provost.

XI.—OF INTERCESSION.

Special Intercession shall be offered up for those who, on tempestuous nights, are in peril of shipwreck, or of other disasters at sea, in these or the like words :---

Versicle .--- "Let us pray for those who voyage and are in peril."

Response.—" Hear us, O GOD of our salvation, Thou that art the hope of all the ends of the earth, and of them that remain in the broad sea."

Collect.—" O GOD, Who, when Thy Apostle Peter walked on the waves savedst him with Thy Right Hand, and deliveredst his fellow Apostle Paul the third day from shipwreck on the open sea; favourably hear us, and stretch forth Thy Right Hand to save and defend such as voyage and are in peril, and bring them safely unto the haven where they would be; and mercifully grant that we and all Thy servants may attain unto the haven of everlasting rest; Who livest and reignest with the FATHER and the HOLY GHOST, One GOD, world without end. AMEN."

EPISCOPAL RATIFICATION (1876).

WE, George Richard, by Divine Permission, Bishop of Argyll and The Isles, do by these presents make known unto all faithful persons, that in accordance with the Terms of the Note appended to the Episcopal Ratification in 1853, and with concurrence of George Frederick, Earl of Glasgow, the Founder, and a majority of the Chapter, We have Ratified and Confirmed the above Statutes, with such alterations and additions as were rendered necessary, in prospect of the immediate elevation of the Collegiate Church of the HOLY SPIRIT to the rank of "CATHEDRAL OF THE ISLES," within the United Dioceses.

WE, George Richard, by Divine Permission, Bishop of Argyll and The Isles, Do by these presents make known unto all faithful persons, that, by our Episcopal authority, exercised in accordance with the advice and assent of our Diocesan Synod, rendered in the years Eighteen Hundred and Fifty-three and Eighteen Hundred and Seventy-five, respectively, We do now solemnly declare this "Collegiate Church of the HOLY SPIRIT," in the Island of Cumbrae, to be "The Cathedral Church of The Isles," within the United Dioceses of Argyll and The Isles.

Preparation for Holy Orders.

STUDENTS" in Theology are received to be prepared for Holy Orders. If Graduates they are expected to reside one Collegiate year; if Non-Graduates, two years.

All applications for admission must be accompanied by a Testimonial of good conduct, for which the following Form is suggested :---

"I, A. B., whose name is hereunto subscribed, do hereby certify that I have known C. D. for years last past, and believe in my conscience that he is a fit person to be received as a Student at the Theological College, Isle of Cumbrae, as a future Candidate for Holy Orders.

Examinations are held at the close of each Term, which the Students are expected to pass to the satisfaction of the Provost.

COURSE OF STUDY.

THE Course of Study embraces the following Books and Subjects :---

Holy Scripture—The Old Testament, some book or books of. The New Testament in Greek. The Criticism and Interpretation of the New Testament.

Doctrine—The XXXIX Articles. Pearson on the Creed. Hooker's Ecclesiastical Polity: Book V. Butler's Analogy. The Church Catechism.

Ecclesiastical History—The History of the Church for the first five centuries. The History of the Church of England. The History of the Church of Scotland.

Prayer Book—Liturgies Ancient and Modern. The Rationale and Structure of the Prayer Book. The Principles of Divine Service. Lectures are also given throughout the year on some one or other of the writings of the early Fathers. Instruction is also given in the composition of Sermons, and in Pastoral Theology.

SCHOLARSHIPS.

THERE are at present two Scholarships or Exhibitions connected with this College, which are of the value of $\pounds 50$ per annum each. They are open to competition, preference being given to ex-Choristers and sons of Clergy serving the Church in Scotland.

The following Declaration is required to be made by each Scholar on his appointment :---

"I, A.B., appointed to a Scholarship in the College of the HOLY SPIRIT, Isle of Cumbrae, tenable by me as a Scholar preparing for Ordination in the Church of Scotland, do hereby solemnly promise and declare, that, if it shall please the great Head of the Church to continue unto me the grace of Vocation to Holy Orders, I will serve in the Ministry of the aforesaid Church of Scotland for the space of *Five* years from the date of my Ordination to the Priesthood. And I do hereby also undertake, in the event of my being released from this obligation or serving the Church in any benefice or curacy in the Church of England, or in any other Church in communion with her before the completion of the said *Five* years' service, to refund to the College of the HOLY SPIRIT, by such annual instalments as shall be determined on by the Provost and Chapter, the amount of the Scholarship which I shall have received solely with a view to entering the service of the Church of Scotland. *

Preparation for the Universities.

In another department of the College, Students are received who are preparing for Matriculation at any of the Universities. Such Students must be above sixteen years of age, and are expected to comply in all respects with the regulations of the College.

* In order to prevent any possible misunderstanding in the Declaration to be made by Exhibitioners, it was resolved that, "Wherever in the said Declaration, or in this Chapter-Book, the words 'Church of Scotland' occur, they shall be taken to mean what is commonly called the 'Episcopal Church in Scotland.'"—Minutes of Meeting of Chapter, Sept. 30, 1872.

Vacation Students.

MEMBERS of the Universities are admitted to read during the Long Vacation, or at any other period of the year when there may be Rooms vacant.

Clerical Visitors.

CLERGY requiring rest from overwork, or desiring a quiet retreat for the purpose of prosecuting their studies are received in this College, when there are any Rooms vacant, on the payment of a moderate sum for the expense of their Board. Such Visitors are permitted the use of the Canons' Library as a Common Room. Clergy desirous of admission are requested to make application to the Provost.

Regulations of the College.

1.—All Members of the College are expected to wear their Academical dress at Lectures, Breakfast, and Dinner—and when attending Services in the Cathedral, if they are not in the Choir.

2.-Students are required to attend daily Mattins and Evensong.

3.—Smoking is strictly prohibited in Passages and Cloisters.

4.—All lights are put out in Passages and Common Rooms at 11 p.m., at which hour all Students must be in College.

5.—Leave must be obtained from the Provost before any Student leaves the Island.

6.—Hours—Chapel, 8 a.m.; Breakfast, 8-30 a.m.; Luncheon, 1 p.m.; Chapel, 5-15 p.m.; Dinner, 6 (Sundays, 7-30) p.m.

Scale of Charges.

I.—THE PROVOST, CANONS, AND RESIDENT CLERGY. At the rate of $\pounds 2$ 2s. a-week for Board and Domus.

II.—STUDENTS preparing for the Universities, £125 per annum. Students preparing for Holy Orders, £95 per annum. Some reduction may be made in the case of Scholars.

III.—STUDENTS FOR SHORTER PERIODS. (a) Theological Students at the rate of £3 3s. a-week for Board, &c., and Tuition. (b) Other Students—Such further sum as the Provost may decide upon in each case.

IV.—VISITORS AT THE COLLEGE. At the rate of 7s. a-day, or $\pounds 2$ 2s. a-week.

V.—THE CLERGY OF THE SCOTTISH EPISCOPAL CHURCH. At a reduced rate of payment.

VI.—SINGLE MEALS. Breakfast, 2s.; Lunch, without Meat, 6d.; Lunch, with Meat, 1s.; Dinner, 2s. 6d.; Tea, 6d. An additional charge of 6d a-day for attendance.

THE RESIDENT CLERGY shall pay their accounts on May 15, August 1, November 11, and February 2, being the Scottish Quarter Days.

STUDENTS are expected to pay their accounts at the end of each Term before going down.

Choristers.

A CERTAIN number of boys duly qualified to sing in the Choir are received on the Foundation of the College. According to present arrangements they are under the charge of the Organist, and reside with him in a house adjoining the College grounds. They receive instruction in Music and a plain Elementary Education, and if found suitable are (at the age of sixteen) eligible, after competition, to Scholarships on the Foundation.

Terms—£12 12s. per annum. Two months holidays in the year, generally during the months of May and November.

"JOHNSTON PRIZES."—The late Mrs. Jane Johnston, for many years housekeeper to the Right Hon. Julia, Countess of Glasgow, having bequeathed a legacy of £40 to the Collegiate Church, it was determined by the Provost and Chapter to invest the money —the interest thereon to be expended annually, at Easter—on two Prizes, called the "Johnston Prizes," to be given to the two Choristers who shall be found the most distinguished for their proficiency and general conduct during the preceding year.

Awarded in 1875 to William Channel Fry and Richard Hudson; in 1876 to Richard Hudson and William Hudson; in 1877 to Harold Philip Lucy and William Stanley Hudson.




